PUBLIC HEARING

Mayor Cummings opened the Public Hearing on Local Law #2 at 6:00 p.m.

Questions from the public:

Joe Carroll, Shethar Street, voiced concern over the removal of two hour parking. He used tour buses as an example of cars left on the streets for an extended amount of time and using up parking spots, limiting spots for the business districts customers. He spoke to Community Bank and they said they would allow patrons of tour buses to park in their lot on the weekends.

Bill Bartz, 12 William Street, suggested that if parking is changed to one side on Williams Street that the speed limit should be reduced to 25 mph.

Dick Leonberger, 11 William Street, voiced concern about double parking and blocking William Street when the Village Tavern and Maloney's get deliveries or limo's drop off guests.

With no further questions from the public, on a motion to Trustee Pulver and seconded by Trustee Green and carried, all voting Aye to adjourn the Public Hearing at 6:25 p.m.
